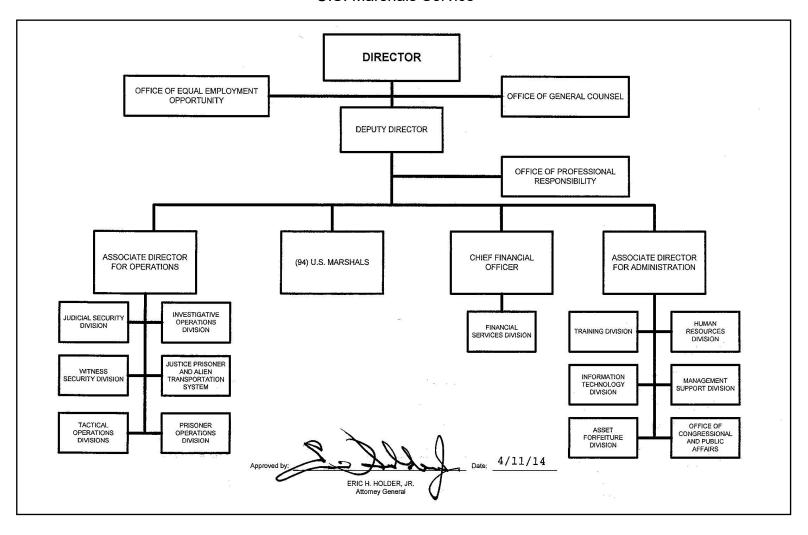
Organizational Chart

2 <u>Detention Daily Cost Adjustment - FPD</u> This request recosts the estimated 2023 state and local jail days using the anticipated 2024 increase in the national jail day rate average. The requested increase reflects the additional resources required to fund the same number of jail days in 2024 as in 2023. Transfers amounting to \$97,900,000 include \$56,000,000 from Bureau of Prisons Salaries and Expenses (BOP S&E), \$11,000,000 from Community Oriented Policing Services Management and Administration (COPS M&A), \$11,700,000 from Office of Justice Programs (OJP) State and Local Law Enforcement Assistance (SLLEA) State Criminal Alien Assistance Program (SCAAP), and \$19,200,000 from USMS Salaries and Expenses Annual (15-0324-22) to support FPD account solvency.

Carryover:

FPD carried forward \$36,093,942 from funds provided in FY 2021.

Recoveries/Refunds:

Recoveries/Refunds amounting to \$15,745,716 include \$15,468,159 recoveries from prior year obligations to fund regular detention activities consistent with the manner in which it was originally appropriated. A total of \$277,557 collections from state and local for prisoner transport is also included.

U.S. Marshals Service Federal Prisoner Detention

- 1. Per the House Report associated with the Departments of Commerce, Justice, Science, and Related Agencies Appropriations Bill, 2023, page 72:
 The USMS is directed to continue to submit monthly reports on individuals in the detention system, as directed in the explanatory statement accompanying the fiscal year 2022 Appropriations Act, and to anticipate funding needs so as to avoid funding shortfalls or a need for emergency reprogramming.
- 2. Per the House Report associated with the Departments of Commerce, Justice, Science, and Related Agencies Appropriations Bill, 2023, page 72-73: The USMS is directed to publish a report and provide the Committee a briefing, not later than 90 days after the date of enactment of this Act, on the impact of E.O. 14006 on the USMS, to include the effects on custody and transportation logistics, budgets, finances, as well as on the U.S. Courts and communities they serve, including proximity to courts, and the ways in which these impacts are being mitigated.
