## **Executive Office for Immigration Review Announces Four New Assistant Chief Immigration Judges**

FALLS CHURCH, Va. – The Executive Office for Immigration Review (EOIR) today announced four new assistant chief immigration judges (ACIJJs). ACIJJs are responsible for overseeing the operations of the immigration courts to which they are assigned. In addition to their management responsibilities, these Attorney General appointees will hear cases.

Biographical information follows:

### **William E. Hanrahan, Assistant Chief Immigration Judge, San Francisco Immigration Court**

William E. Hanrahan was appointed as an assistant chief immigration judge, based in San Francisco, in March 2020. Judge Hanrahan earned a Bachelor of Science in 1982 from the University of Wisconsin-Green Bay and a Juris Doctor in 1988 from Hamline University School of Law. From 2018 to 2020, he served as chief judge of the Fifth Judicial District of Wisconsin. From 2016 to 2018, he served as a Wisconsin deputy chief judge, and from 2007 to 2016, he served as a circuit court judge. From 1998 to 2007, he served as an assistant attorney general for the Wisconsin Department of Justice. From 1988 to 1998, he served as an assistant district attorney, in Milwaukee County. Judge Hanrahan is a member of the State Bar of Wisconsin.

### **Karen E. Mayberry, Assistant Chief Immigration Judge, Arlington Immigration Court**

Karen E. Mayberry was appointed as an assistant chief immigration judge, based in Arlington, in March 2020. Judge Mayberry earned a Bachelor of Arts in 1983 from Rutgers University and a Juris Doctor in 1986 from the Kansas University School of Law. From 1986 to 1987, she served as a tax attorney in Wichita, Kansas. From 1987 to 1989, she served as an assistant appellate defender in Topeka, Kansas.
