Also, the FY 2021 President's Budget included an additional 62 DI positions and the registrant fee to accommodate the new positions was increased starting in October 2020.
Drug Enforcement Administration	Sensitive Investigative Unit (SIU) Basic Training Course No. 109	Moorefield, West Virginia	8/9/2021	9/10/2021	9	48	49	\$ 247,643	The Sensitive Investigative Unit (SIU) Basic Course No. 109 is a mandated component of DEA's SIU Program through which foreign law enforcement personnel selected for participation in the SIU Program are vetted. The purpose of the SIU Program is to train, equip, and support specialized units within host nation police forces and to develop and share intelligence in order to target, disrupt, and prosecute major transnational criminal organizations. Participants selected for the program are expected to learn critical enforcement and surveillance techniques, including interview techniques, operation planning, intelligence, and wiretap management. Several elements of the training, such as raids training, firearms, tactical training, convoy attacks, rough terrain driving, and other physical activities, require in-person, hands-on participation in a controlled environment overseen by DEA's Office of Training.

The DRC prepares Special Agents to safely and effectively execute force-protection duties and other skills needed to be self-sufficient for up to 72 hours. In addition to receiving a block of legal instruction from ATF's National Coordination Center (NCC), Special Agents receive training in Swift Water & Urban Rescue, Chainsaw Awareness, Convoy & Off-Road Driving, Vehicle Recovery Equipment & Techniques, Medical Training, Land Navigation, Vehicle Window Forced Breaching, Firewood Harvesting & Fire Starting, River Crossing, Improvised Shelter Building, Explosives Demonstration, Tactical Refresh, Reporting of an Incident, and how to identify and establish a Helicopter Landing Zone (HLZ).
