) **SCHEDULING ORDER**
SPECIFYING PROCEDURES

22 With this Scheduling Order Specifying Procedures, the Court orders the
23 following concerning the dates and procedures in this case. Counsel are ordered to
24 be completely familiar with the Federal Rules of Civil Procedure, the Local Rules
25 of the Central District of California, and the FAQ's about Judges' Procedures and
26 Schedules posted by these Chambers on the Central District website at
27 <http://www.cacd.uscourts.gov> . If there is a first appearance by any party after the
28 date of this Order, Plaintiff counsel shall give a copy of this Order to that party.

1 1. Discovery. The Court sets a discovery cutoff on the date stated in the
2 caption of this Order. The following discovery schedule shall apply.

3 1.1 Depositions. All depositions shall occur on or before the
4 discovery cutoff date. A deposition which was started on or before the discovery
5 cutoff date may continue beyond the cutoff date, if necessary for completion.

6 1.2 Other Discovery. All interrogatories, requests for admission,
7 requests for production, or the like, shall be served at least forty-five days before
8 the discovery cutoff date. The Court will not approve stipulations between counsel
9 which permit discovery responses to be served after the cutoff date except in
10 unusual circumstances and upon a showing of good cause.

11 1.3 Discovery Motions. The Magistrate Judge assigned to this case
12 shall hear all discovery motions. Discovery motions shall be filed and served as
13 soon as possible and never later than 30 days after the discovery cutoff date. The
14 parties are ordered to strictly comply with the requirements of all Local Rules at
15 Local Rule 37 et seq. in preparing and filing Discovery Motions. The Court
16 expects counsel to resolve most discovery problems among themselves in a
17 courteous, reasonable, and professional manner. Frequent resort to the Court for
18 guidance in discovery is generally unnecessary.

19 1.4 Expert Discovery. The discovery cutoff provisions in this
20 Order include expert discovery, unless otherwise ordered by the Court. Unless the
21 parties otherwise stipulate in writing and obtain the Court's approval, the Court
22 orders the sequence of disclosures as provided by Fed. R. Civ. P. 26(a)(2)(C),
23 except that the initial disclosure shall occur at least 120 (not 90) days before trial,
24 and if an expert is identified under Fed. R. Civ. P. 26(a)(2)(C)(ii), any deposition
25 of such expert shall occur as soon as reasonably possible, but may occur after the
26 discovery cutoff date.

27 2. Final Pretrial Conference. The Court sets a Final Pretrial
28 Conference under Fed. R. Civ. P. 16 on the date stated in the caption of this Order.

1 The parties are ordered to strictly comply with the requirements of all Local Rules
2 at Local Rule 16 et seq. The proposed final Pretrial Conference Order shall be in
3 the format set forth in Appendix A to the Local Rules, and state the settlement
4 procedure that was followed.

5 3. Joinder and Amendment Motions. Absent exceptional circumstances,
6 any motion to join another party or to amend a pleading shall be filed and served
7 within 60 days after the date of this Order and noticed for a hearing occurring
8 within 90 days after the date of this Order.

9 4. Summary Judgment or Partial Summary Judgment Motions. Such
10 motions shall be noticed for a hearing occurring not less than 30 days before the
11 Final Pretrial Conference, unless otherwise allowed by the Court.

12 5. Settlement. In every case, if the parties and attorneys are unable to
13 resolve the matter on their own, the Court requires that there be a settlement
14 conference before an independent settlement officer, to be conducted before the
15 Final Pretrial Conference. Counsel may agree on an appropriate procedure, such as
16 a settlement conference with a magistrate judge, retired judge, or attorney, or
17 similar alternative devised by counsel. The proposed Final Pretrial Conference
18 Order shall state the settlement procedure that was followed.

19 6. Trials. The Court sets a trial date on the date stated in the caption of
20 this Order. The following procedures shall apply.

21 6.1 In limine motions (jury trials). Any motion in limine shall be
22 filed and served not later than ten court days before the Final Pretrial Conference,
23 and any opposition shall be filed and served five court days before the Final
24 Pretrial Conference.

25 6.2 Voir dire questions (jury trials). The Court will question jurors
26 concerning standard topics. Any special questions or topics requested to be put to
27 prospective jurors by the Court on voir dire shall be filed and served at least five
28 court days before trial.

1 6.3 Jury instructions (jury trials). The Court prefers to use
2 instructions from the Manual of Model Jury Instructions for the Ninth Circuit,
3 following all the Local Rules at Local Rule 51 *et seq.* At least five court days
4 before trial, counsel shall file with the Court the following:

5 6.3.1 A joint set of jury instructions on which there is
6 agreement. (Plaintiff counsel has the burden of preparing
7 the joint set of jury instructions.)

8 6.3.2 Each party's proposed jury instructions which are
9 objected to by any other party, accompanied by points
10 and authorities in support of those instructions.

11 6.3.3 Each party's points and authorities supporting their
12 objections to another party's proposed jury instructions.

13 6.4 Special verdict in jury trials. If any special forms of verdict are
14 requested, they shall be prepared, filed, and served under Local Rules 49-1 and
15 49-2.

16 6.5 Exhibits. Unless an electronic alternative is approved by the
17 Court, counsel shall prepare an original set and a copy set of trial exhibits in 3-ring
18 binders, each tabbed down the right side with the exhibit number, prefaced by an
19 index of each exhibit, following Local Rule 26-3 in numbering exhibits.

20 6.6 Submission at trial. Counsel shall submit the following to the
21 Courtroom Deputy Clerk on the first day of trial:

22 6.6.1 The original exhibits binder set with the Court's exhibit
23 tags attached and filled out showing the case number,
24 case name, and exhibit number. (Exhibit tags must be
25 attached so as not to cover exhibit text.)

26 6.6.2 The copy exhibit binder set for use by the Judge.

27 6.6.3 Three copies of exhibit lists, showing which exhibits may
28 be received into evidence without objection.

6.6.4 Three copies of witness lists.

6.6.5 A transcript or copy of any deposition or other discovery response to be read to the jury, following Local Rule 16-2.7.

6.6.6 (Jury trials) A very short description of the case approved by all parties to be read to the jury at the beginning of the trial.

6.7 Trial times. Trial times generally are 9:00 a.m. to 12:00 p.m. and 1:30 p.m. to 4:30 p.m. Tuesday through Thursday, and 8:00 a.m. to 1:30 p.m. on Friday.

6.8 Witnesses. If counsel runs out of witnesses, the Court may deem that counsel has rested. Counsel must keep opposing counsel informed about the order of witnesses, always informing opposing counsel of the witness for the next court day before 5:00 p.m. of the previous court day. Only one attorney per party shall examine and defend a witness.

6.9 Admission of Exhibits. When counsel thinks an exhibit is admissible and should be admitted, counsel should move its admission.

6.10 Objections. Objections should be brief, stating only, “Objection” followed by the specific legal ground such as “Hearsay” or “403.”

6.11 Decorum. Trials will be conducted in a dignified manner, following the traditional rules of trial decorum. Show respect for the trial process by being on time. Do not address witnesses over age 14 by their first names. Most examination and argument should be done at the lectern. The Court recognizes that at times it is necessary to enter the well in this courtroom.
