SCHEDULING ORDER

On January 14, 1997 at 3:00 p.m. (EST), a follow up telephonic prehearing conference was held in this matter. Appearing on behalf of the complainant was Orin Alexis, and on behalf of respondent was Regina Alberini Young. The principal focus of the conference was a schedule for further proceedings, as well as ongoing settlement discussions.

Both parties indicated that they have served written discovery requests upon the other party and that responses are not yet due. Any additional discovery must be initiated prior to February 27, 1998.

The cut off date for filing any dispositive motions is March 31, 1998. The non-moving party shall have 30 days to respond to any such motion.

Any party wishing an adjustment in the schedule shall first contact the opposing party and seek agreement to any proposed alteration. Any reasonable agreement by the parties will be accepted.

Both parties were encouraged to continue a good faith settlement dialog.
