ORDER DISMISSING PROCEEDING

(January 7, 1998)

Complainant has filed a Joint Motion to Dismiss, because the parties, including the charging party, have entered into a Settlement Agreement and General Release (Settlement Agreement) which disposes of all the issue in this case and have agreed to the dismissal of the action. Complainant has provided a copy of the Settlement Agreement to the Court.

The OCAHO Rules of Practice and Procedure provide that when parties or their authorized representatives enter into a proposed settlement agreement, they may submit to the Judge either a proposed agreement containing consent findings and a proposed decision and order or notify the Judge that the parties have reached a full settlement and have agreed to the dismissal of the action. 28 C.F.R. § 68.14(a).

In this case, the parties have not submitted consent findings. However, the parties have reached a full settlement, which resolves all disputed issues. Therefore, pursuant to 28 C.F.R. §68.14(a)(2), the Joint Motion to Dismiss is granted, and this case is dismissed with prejudice.
