ORDER OF DISMISSAL, SETTLED
(May 11, 1998)

The parties, by motion filed this date, request an order of dismissal, settled. In support they attach a settlement agreement executed by Complainant on February 19, 1998, and by Respondent on April 20, 1998. My prior Order issued April 21, 1998 provides background to understanding the delay between those dates, reflecting Respondent's request for an opportunity to review the then-pending agreed disposition.

Although the Motion to Dismiss the Complaint is not signed, a letter of transmittal dated May 5, 1998 is signed by counsel for Complainant, both parties signed the underlying agreement, and Respondent orally expressed her consent as confirmed by the April 21 Order. Having reviewed the agreement, in order to give effect to the intent of the parties, I see no reason to withhold approval, noting, however, that the dates for compliance have been overtaken, an immaterial consideration in light of the understanding that the parties are in agreement on that score.

Respondent will cease and desist from any violations of Sections 274A(a)(1)(A) and 274A(a)(1) (B) of the Immigration and Nationality Act, codified at 8 U.S.C. §§ 1324a(a)(1)(A) and (a) (1)(B).

This Order dismisses the proceeding, settled.
