## **Assistant Chief Immigration Judge**

## James F. McCarthy III, Assistant Chief Immigration Judge, Cleveland Immigration Court

Attorney General William Barr appointed James F. McCarthy III to begin supervisory immigration court duties and hearing cases in May 2019. He oversees the Cleveland Immigration Court.
