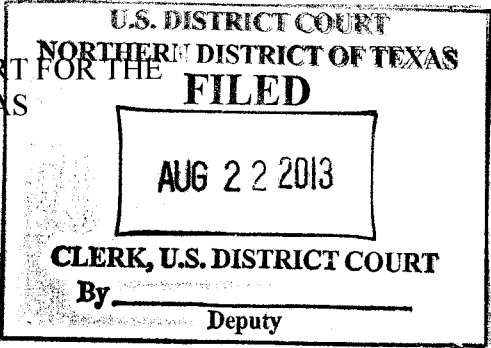

**STIPULATED ORDER OF PERMANENT INJUNCTION**  
**AGAINST KARENA MONDRIANH**

The United States has filed a complaint for permanent injunction under Internal Revenue Code (I.R.C.) §§ 7402(a), 7407, and 7408(a) against Karena Mondrianh. Mondrianh, without admitting the allegations contained in the complaint, hereby consents to the entry, without further notice, of this Stipulated Order of Permanent Injunction.

Karena Mondrianh enters into this Stipulated Order of Permanent Injunction voluntarily and waives the entry of findings of fact and conclusions of law. Karena Mondrianh also waives any right she may have to appeal from this Stipulated Order of Permanent Injunction. Karena Mondrianh further understands and agrees that the Court will retain jurisdiction over this matter for the purpose of implementing and enforcing this order, and Karena Mondrianh understands

that if she violates the order, she may be subject to civil and criminal sanctions for contempt of court.

Karena Mondrianh, pursuant to 31 C.F.R. § 10.8(a), acknowledges that she is subject to the duties and restrictions relating to practice and to sanctions contained in 31 C.F.R., Subtitle A, Part 10, Subparts B and C, respectively; and understands that entry of this Stipulated Order of Permanent Injunction shall be deemed a consent by her to be sanctioned pursuant to 31 C.F.R. § 10.61(b), in the manner and to the extent set forth herein. Karena Mondrianh agrees, without further proceedings, to immediate revocation of her preparer tax identification number (PTIN), issued pursuant to 26 U.S.C. § 6109, and she consents to disbarment from practice before the Internal Revenue Service in any capacity.

The parties agree that entry of this Stipulated Order of Permanent Injunction resolves only this civil injunction action, and neither precludes the government from pursuing any other current or future civil or criminal matters or proceedings, nor precludes the defendant from contesting her liability in any matter or proceeding.

1. **IT IS HEREBY ORDERED** that Karena Mondrianh and her representatives, agents, servants, employees and anyone in active concert or participation with her, are PERMANENTLY ENJOINED, pursuant to I.R.C. §§ 7402, 7407, and 7408, effective from entry of this Order from directly or indirectly:

- a. Preparing or filing, or assisting in, or directing the preparation or filing of any federal tax return, amended return, or other federal tax documents or forms for any other person or entity;
- b. Directly or indirectly advising anyone to violate internal revenue laws or unlawfully evade the assessment or collection of their federal tax liabilities,

including promoting, selling, or advocating the misuse of false IRS Forms 1040, 1040X, 1120, 1065, 2555, Schedule C, or other IRS forms;

- c. Filing, providing forms for, or otherwise aiding and abetting the filing of false IRS Forms 1040, 1040X, 1120, 1065, 2555, Schedule C, or any other IRS forms for herself or others;
- d. Engaging in conduct subject to penalty under I.R.C. §§ 6694 or 6701, including preparing and filing tax returns and other documents that understate the tax liabilities of others;
- e. Engaging in conduct subject to penalty under I.R.C. § 7212(a), including interfering with or impeding the IRS's examination of federal tax returns;
- f. Preparing her own federal income tax return in a manner that fabricates expenses or purposely understates her own tax liability;
- g. Representing anyone other than herself before the IRS;
- h. Engaging in any other conduct that is subject to penalty under the I.R.C. or that interferes with the proper administration and enforcement of the internal revenue laws.

2. **IT IS HEREBY ORDERED** that, pursuant to I.R.C. §§ 7402(a) and 7408, Karena Mondrianh shall provide a copy of this permanent injunction to all past and present customers within 15 days of entry of the injunction, and provide to counsel for the United States within 30 days a signed and dated acknowledgment of receipt of this Order for each person to whom Karena Mondrianh provided a copy of this Order in compliance with this paragraph.


3. **IT IS HEREBY ORDERED** that, pursuant to I.R.C. §§ 7402(a) and 7408, Karena Mondrianh shall provide a copy of this permanent injunction to all past and present principals,

officers, managers, representatives, agents, servants, employees, and attorneys of the entities used in furtherance of the schemes alleged in the complaint within 15 days of entry of the injunction, and provide to counsel for the United States within 30 days a signed and dated acknowledgment of receipt of this Order for each person to whom Karena Mondrianh provided a copy of this Order in compliance with this paragraph.


4. **IT IS HEREBY ORDERED** that the United States may engage in full post-judgment discovery to monitor compliance with the injunction.




