#### **Overview**

OJJDP Tribal Youth Program & Tribal Juvenile Accountability grants further the Department's mission by enhancing opportunities for federally recognized tribes to provide comprehensive and quality programs for youth in Indian Country



#### **Tribal Youth Programs**

#### **TYP PROGRAM CATEGORIES**

Since 1999 OJJDP has awarded 314 grants to federally recognized tribes throughout the nation to:

- Provide prevention services to impact risk factors for delinquency
- **II.** Provide interventions for court-involved tribal youth
- Improve the tribal juvenile justice system
- **IV.** Provide alcohol and drug abuse prevention programs
- v. Provide mental health program services and resources

## Tribal Juvenile Accountability Discretionary Grants (T-JADG)

#### **T-JADG Mission**

To develop and implement programs that hold tribal youth accountable for their delinquent behavior and strengthen tribal juvenile justice systems



## Juvenile Accountability Block Program (JABG)

The JABG Program, reauthorized in 2005, supports state agencies and units of local government, including tribal governments, in efforts to strengthen juvenile justice systems within 17 purpose areas

- Congressional appropriations determine each year's JABG allocation
- JABG funds are distributed on a formula basis
- Two percent of JABG funds are used for a "Tribal Set-Aside" for the Tribal Juvenile Accountability Discretionary Grants

## Tribal Juvenile Accountability Discretionary Grants (T-JADG)

#### **T-JADG Program Purpose Areas**

- Graduated sanctions for juvenile offenders
- Construction of juvenile facilities (50% "match required")
- Hiring judges, probation officers, and public defenders (includes pretrial services)
- Hiring prosecutors
- Funding to prosecutors (includes technology, equipment, and training)
- Training programs for law enforcement officers and court personnel
- Juvenile Gun Courts

## T-JADG Program Purpose Areas (cont.)

- Juvenile Drug Courts
- Juvenile records systems
- Interagency information sharing program
- Accountability –based programs
- Risk and needs assessments (includes mental health screening, substance abuse testing, and treatment)
- School safety accountability programs
- Restorative justice programs
- Juvenile courts and probation programs
- Hiring and training detention and corrections personnel
- Re-entry of juvenile offenders

## **Building Brighter Futures**

OJJDP will award up to 17.45 million dollars to federally recognized tribes for 3 & 4 year budget and project periods.

### **Award Information for FY 2010**

OJJDP will make the following awards by Sept. 30, 2010:

- Tribal Youth Programs Grants: 10 million up to 25 awards
- Tribal Juvenile Accountability Discretionary Grants: 1.5 million up to 5 awards
- Develop new Demonstration Program Grants: 1.35 million up to 12 awards
- Award amount will cover the entire requested project period
- All awards are subject to the availability of appropriated funds
- OJJDP anticipates that any awards under this solicitation will be made by September 30, 2010

#### **OJJDP's T & TA Mission**

The funding of a T & TA Center for OJJDP TYP, T-JADG furthers the department's mission by providing T & TA to assist federally recognized tribes to reduce delinquency among tribal youth through T/TA in strategic planning, implementation, data collection, evaluation, and sustainability

OJJDP, through EDC's Tribal Youth Training & Technical Assistance Center provides T & TA to Tribal Youth program grantees, as well as to all federally recognized tribes

- Every Tribal Youth Program grantee is assigned a Technical Assistance Specialist
- EDC's Tribal Youth Technical Assistance Specialists have lived and worked in Indian Country and bring a unique combination of content expertise and sensitivity to the ongoing concerns of tribal communities
