## Summary of Recent Court Cases

### Northwest Washington man convicted of February 2008 shooting

**25-year-old Manuel Nunez-Sandoval**, of Northwest Washington, D.C., was found guilty of Assault with Intent to Kill while Armed, Aggravated Assault while Armed, two counts of Possession of a Firearm During a Crime of Violence and Carrying a Pistol without a License, for the February 20, 2008, shooting of a 19-year-old man.

**Adane Kebede**, a 53-year-old Ethiopian national, has pled guilty to murdering a fellow Ethiopian in December 2006 during a brazen, broad daylight shooting in Northwest Washington, D.C.

**Angalia Moore, of Farragut Street, NW, Washington, D.C.**, was arraigned February 5, 2009 on a 12-count indictment charging mail fraud, wire fraud, and theft while she worked as a Chief Financial Officer for a District of Columbia company which provided services for the mentally ill.

## *THE COURT REPORT*

### **Northwest Washington man convicted of February 2008 shooting**

United States Attorney Jeffrey A. Taylor announced that on February 17, 2009, Manuel Nunez-Sandoval, 25, of Northwest Washington, D.C., was found guilty by a jury in the Superior Court of the District of Columbia of Assault with Intent to Kill while Armed, Aggravated Assault while Armed, two counts of Possession of a Firearm During a Crime of Violence and Carrying a Pistol without a License, for the February 20, 2008, shooting of a 19-year-old man. Nunez faces a statutory minimum of ten years' incarceration for these crimes when he is sentenced by the Honorable Gerald I. Fisher on April 17, 2009. After completion of his sentence, Nunez, an illegal alien, faces deportation to El Salvador.

The government's evidence at trial established that on February 20, 2008, Nunez and an unknown man were involved in an argument with the victim in the case. That argument occurred in front of Nunez's apartment building in the 1400 block of Otis Place, NW (PSA 302). Following the argument, Nunez went into the apartment building and changed the clothes that he was seen wearing. Minutes later, Nunez came out of the building wearing a hooded sweatshirt. Nunez approached the victim, who remained in the block. Nunez pulled a revolver and shot the victim in the upper chest. As the victim fell to the pavement, Nunez walked closer to him and fired four additional shots, striking him in the back. Nunez then ran away. The shooting was witnessed by a man who testified that he recognized Nunez from the neighborhood. That witness identified Nunez in court as the person who shot the victim. Additionally, two witnesses testified that they later overheard Nunez bragging about shooting the victim while in a bar near where the shooting occurred.

### **Ethiopian national pleads guilty to murdering fellow Ethiopian in brazen, daylight shooting**

A 53-year-old Ethiopian national, Adane Kebede, has pled guilty to murdering a fellow Ethiopian in December 2006 during a brazen, broad daylight shooting in Northwest Washington, D.C., U.S. Attorney Jeffrey A. Taylor announced today.

Kebede, of Oakland, California, entered his guilty plea earlier today in the Superior Court of the District of Columbia to Second Degree Murder while Armed and Possession of a Firearm Firing a Crime of Violence or Dangerous Offense in connection with the fatal shooting of 51-year-old Abiy Bezabih on December 18, 2006. The shooting occurred near the intersection of 12<sup>th</sup> and U Streets, NW, in front of a 7-11, at about 3:30 p.m. Sentencing is scheduled before the Honorable Frederick Weisberg for May 1, 2009. The defendant faces up to 55 years in prison and risks deportation at the conclusion of his sentence.

At today's guilty plea hearing, the defendant was placed under oath and admitted that on December 18, 2006, he shot and killed Abiy Bezabih. He further admitted that he and Mr. Bezabih were born in the same town in Ethiopia, and knew each other growing up. Kebede

emigrated to the United States in the early 1970s and eventually settled in Oakland, California, where he worked as a security guard. At one point, Mr. Bezabih asked Kebede to sponsor him for citizenship in the United States, but Kebede refused. Mr. Bezabih eventually emigrated to the United States much later and settled in the Washington, D.C. area.

In the Fall of 2006, a childhood friend of both Kebede and Mr. Bezabih came to the United States from Ethiopia for a vacation. The friend grew up in the same Ethiopian town as Kebede and Mr. Bezabih and, even though the friend was somewhat older than Kebede and Mr. Bezabih, he knew both men. During that visit, Kebede learned that Mr. Bezabih was living in Washington, D.C., and stated that he would like to visit him.

The friend came to Washington, D.C. in early December and Kebede made plans to travel to Washington as well. His plans were to visit with the friend and Mr. Bezabih. Kebede arrived in Washington, D.C. on December 15, 2006, and later checked into a hotel in Germantown, MD, the same day. Among the items that Kebede brought with him were a Highpoint 9mm semi-automatic pistol and ammunition for the pistol.

On the morning of December 18, 2006, Kebede arranged to meet with Mr. Bezabih and the mutual childhood friend from Ethiopia at Dukem restaurant, which is located at the intersection of 12<sup>th</sup> and U Streets, NW. The friend and Kebede arrived about 2:00 p.m. and had some food. Mr. Bezabih arrived about 3:30 p.m. He parked across U Street from the restaurant, in front of the 7-11. The friend and Kebede exited the restaurant and crossed the street to greet Mr. Bezabih.

The friend went first and reached Mr. Bezabih at the curb in front of the 7-11. The friend greeted Mr. Bezabih, then Kebede followed. Kebede approached Mr. Bezabih and pointed a handgun towards him. Kebede fired one shot into Mr. Bezabih, striking him in the neck, and Mr. Bezabih slowly collapsed onto the ground. Kebede then fled the scene. He made his way to Whitelaw's store at the intersection of 13<sup>th</sup> and T Streets, NW. Kebede went inside and inquired how he could hail a cab into Maryland. When he exited the store, a police officer detained him. The police found in Kebede's pocket the same Highpoint pistol that he had used to shoot Mr. Bezabih, and \$3,900 in U.S. currency.

Abiy Bezabih died from the gunshot wound inflicted by Adane Kebede. The medical examiner conducted an autopsy and concluded that the cause of death was a single gunshot wound to the body. The manner of death was homicide.

## ***DISTRICT COURT CASES***

**A District woman, Angalia Moore, was arraigned February 5, 2009 on a 12-count indictment charging mail fraud, wire fraud, and theft.**

Moore, 54, of Farragut Street, NW, Washington, D.C., also faces forfeiture of the approximate \$200,000 in money alleged to have been stolen. The case has been assigned to U.S. District Judge Ellen Segal Huvelle and is set for a status hearing on February 17, 2009. If convicted of all counts at trial, Moore could face up to 37 to 46 months in prison under the Federal Sentencing Guidelines.

According to the indictment, which was returned on February 3, 2009, and unsealed today, between 2002 and 2005, Moore worked as a Chief Financial Officer for a District of Columbia company which provided services for the mentally ill. She obtained the job claiming, falsely, that she was a Certified Public Accountant and had degrees from both American University and Tulane. While with this company, Moore allegedly stole refund checks, which were payable to her employer. The indictment also alleges that Moore obtained possession of room and board checks, from the mentally ill, their guardians or trustees, or from other sources, made payable to the company, but instead of depositing the checks into her employer's bank account, she instead misappropriated them by depositing them into her own personal bank account without permission.

Later, in 2006, Moore gained employment at a District of Columbia software development firm as their controller, treasurer, and acting Chief Financial Officer. She obtained this employment, again, by falsely representing her CPA status and educational background. While with the software development firm, Moore again allegedly misappropriated a refund check made payable to her employer. She also used her position to wire transfer money to herself or into accounts which she controlled. According to the indictment, Moore also stole money by using the firm's debit card for her own expenses and by filing for expense reimbursements for expenditures which she did not pay from her own funds.

An indictment is merely a formal charge that a defendant has committed a violation of criminal laws. Every defendant is presumed innocent until and unless found guilty.

**A 57-year-old Warren, Indiana man, David L. Franklin, has pled guilty to interstate transportation of child pornography and possession of child pornography.**

**FACTS:** Franklin entered his guilty plea on February 9, 2009 in the U.S. District Court for the District of Columbia before U.S. Magistrate Judge Alan Kay. Franklin faces a mandatory minimum sentence of five years of imprisonment and a maximum sentence of 20 years of imprisonment for interstate transportation of child pornography. The defendant faces a maximum sentence of 10 years of imprisonment for possession of child pornography. Franklin, who is subject to enhanced penalties because the images of child pornography that he transported involved either a prepubescent minor or a minor who had not attained the age of 12 years, is expected to fall within an advisory sentencing guidelines range of 135 to 168 months of imprisonment when he is sentenced by U.S. District Judge Emmet Sullivan on May 13, 2009.

Franklin admitted during Friday's plea proceeding that between August 21, 2008, and August 29, 2008, he communicated on-line, via computer, with an individual who, unbeknownst to Franklin at the time, was a detective with the Metropolitan Police Department of the District of Columbia ("MPD"), working undercover within the District of Columbia. During that same period, Franklin transmitted to the MPD detective, via the Internet, six videos and four still images depicting the sexual abuse, by adult males, of children -- all of whom appeared to be under the age of 10 (and some of whom appeared to be under the age of two).

On September 4, 2008, the MPD detective, along with FBI agents, executed a search warrant at the home of Franklin in Warren, Indiana. On that date, law enforcement officers seized from Franklin's home, among other things, an Acer Aspire laptop. Subsequent forensic analysis of that laptop revealed six videos and four still images depicting the sexual abuse of children by adult males -- each of which previously had been transmitted to the MPD detective by Franklin. Forensic analysis of the laptop also indicates that Franklin transmitted and possessed a total of at least 454 images of child pornography.

This case was brought as part of Project Safe Childhood, a nationwide initiative to combat the growing epidemic of child sexual exploitation and abuse launched in May 2006 by the Department of Justice. Led by U.S. Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section (CEOS), Project Safe Childhood marshals federal, state and local resources to better locate, apprehend and prosecute individuals who exploit children via the Internet, as well as to identify and rescue victims. **Miguel O. Tejada, a Major League Baseball (MLB) player, has pled guilty to misrepresentations to a Congressional Committee ("Committee") investigating the wrongful use of steroids and other performance enhancing drugs in baseball.**

**FACTS:** Tejada, 34, of the Dominican Republic, entered his misdemeanor plea on February 11, 2009 to one count at a hearing in U.S. District Court in the District of Columbia before the Honorable Magistrate Judge Alan Kay. When Tejada is sentenced on March 26, 2009, he faces up to 1 year in prison under the relevant statute, but under the Federal Sentencing Guidelines, he faces a likely sentencing range of probation to 6 months in prison.

At the time of the taking of the guilty plea, Tejada agreed with the facts set forth in the Statement of Offense, a document he signed and which was filed with the Court. According to the Statement of Offense, on August 26, 2005, Congressional Committee staff conducted a transcribed interview in Baltimore, Maryland, of Tejada in the presence of his attorney and a Spanish language interpreter. Although Tejada was not placed under oath, the Committee staff advised Tejada of the importance of providing truthful answers.

As part of the August 26, 2005 interview, Tejada was generally questioned by Committee staff about, among other things, his knowledge of MLB players, including himself, discussing or

using steroids and other banned performance enhancing substances. Tejada told the Committee staff that he never used performance-enhancing drugs and that he had no knowledge of other players using or even talking about steroids or other banned substances.

Tejada admitted today, however, that during the August 26, 2005 Congressional Committee recorded interview, he withheld pertinent information about his knowledge of a teammate's use of steroids and human growth hormone, by refusing and failing to state fully and completely the nature and extent of his knowledge of discussions with other MLB players. Additional information is set forth in the publicly available Statement of Offense.
