The Grand Jury charges that:

COUNT 1

On or about September 23, 2008, in Orleans Parish, in the Eastern District of Louisiana, the defendant, **JOSE ALTUNAR-CRUZ, a/k/a Javier Gonzalez, a/k/a Javier Losano, a/k/a Jose Altunar, a/k/a Jose Carlos Attunio, a/k/a Jose C. Altunar, a/k/a Jose Aitunar**, an alien, was found in the United States after having been officially deported and removed on or around

November 3, 1997, at or around Oakdale, Louisiana, and after having been removed a second time on January 17, 2003, at or near Nogales, Arizona, and not having obtained the express consent of the Secretary of the Department of Homeland Security to reapply for admission to the United States; all in violation of Title 8, United States Code, Sections 1326(a).

NOTICE OF SENTENCING ENHANCEMENT

Now comes the United States of America, by and through Jim Letten, the United States Attorney for the Eastern District of Louisiana, to give notice that on or about September 17, 1997, in the Fayette County District Court, in Lexington, Kentucky, the defendant, **JOSE ALTUNAR-CRUZ, a/k/a Javier Gonzalez, a/k/a Javier Losano, a/k/a Jose Altunar, a/k/a Jose Carlos Attunio, a/k/a Jose C. Altunar, a/k/a Jose Aitunar**, was convicted of a felony; to wit, possession a forged instrument in the second degree.

Because of this conviction, if the defendant is convicted of a violation of Title 8 U.S.C. Section 1326(a), the defendant's sentence will be subject to a maximum sentence of imprisonment of not more than 10 years under Title 8, United States Code, Section 1326(b)(1).
