INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

On or about November 9, 2003, at Philadelphia, in the Eastern District
of Pennsylvania, defendant

CURTIS EDGEFIELD,

having been convicted in a court of the Commonwealth of Pennsylvania of a crime punishable
by imprisonment for a term exceeding one year, knowingly possessed in and affecting interstate
commerce a firearm, that is, a .38 cal. black Taurus International handgun, model number 82,
serial number UH904741, loaded with four rounds of ammunition.

In violation of Title 18, United States Code, Sections 922(g)(1) and 924(e).

NOTICE OF PRIOR CONVICTIONS

THE GRAND JURY FURTHER CHARGES THAT:

Defendant CURTIS EDGEFIELD committed the offense charged in Count 1 of this Indictment after having been convicted in courts of the Commonwealth of Pennsylvania of three violent felony offenses as follows:

1. Robbery-Court of Common Pleas- Philadelphia County, CP number 9610-0437-September 21, 1996
2. Robbery-Court of Common Pleas- Philadelphia County, CP number 9810-0605-May 4, 1998
3. Robbery-Court of Common Pleas- Philadelphia County, CP number 9511-0114 August 18, 1999

In violation of Title 18, United States Code, Section 924(e).

NOTICE OF FORFEITURE

As a result of the violation of Title 18, United States Code, Section 922(g)(1), set forth in Count One of this Indictment, defendant

CURTIS EDGEFIELD

shall forfeit to the United States of America, pursuant to Title 18, United States Code, Section 924(d) and Title 28, United States Code, Section 2461(c), the firearm and ammunition involved in the commission of this offense, including, but not limited to:

- (a) .38 cal. black Taurus International handgun, model number 82, serial number UH904741, loaded with four rounds of ammunition.

All pursuant to Title 28, United States Code, Section 2461(c) and Title 18, United States Code, Section 924(d).
