Based on information provided by Adobe, in order for the PDF to be PDF/A compliant, the data must be encoded and embedded in a tag in the XML.

For the purposes of the uniform reports, use this tag name for the embedded data: <mp:Nickname>

There are other criteria for PDF/A compliance. A tool in Adobe Acrobat 9.0 called *Preflight* can be used to determine compliance.

To perform the Preflight test:

- 1. Open the PDF in Acrobat, select **Advanced > Preflight...**
- 2. Open/expand the **PDF/A Compliance** option. Select **Verify compliance with PDF/A-1a**, and click **Analyze**.

3. Go back to the **Profiles** tab. Select **Verify compliance with PDF/A-1b**, and repeat the steps for PDF/A-1a. The AOUSC is accepting either standard (1a or 1b) for PDF/A compliance.
