By Kimberley A. Strassel May 3, 2018 6:57 p.m. ET 580 COMMENTS The feud that has simmered for months between Congress and the Justice Department erupted this week into a cage match. That's because the House is homing in on the goods.

Until this week, Deputy Attorney General Rod Rosenstein and fellow institutionalists at the department had fought Congress's demands for information with the tools of banal bureaucracy—resist, delay, ignore, negotiate. But Mr. Rosenstein took things to a new level on Tuesday, accusing House Republicans of "threats," extortion and wanting to "rummage" through department documents. A Wednesday New York Times story then dropped a new slur, claiming "Mr. Rosenstein and top FBI officials have come to suspect that some lawmakers were using their oversight authority to gain intelligence about [Special Counsel Bob Mueller's ] investigation so that it could be shared with the White House."

Mr. Rosenstein isn't worried about rummaging. That's a diversion from the department's opposite concern: that it is being asked to comply with very specific—potentially very revealing—demands. Two House sources confirm for me that the Justice Department was recently delivered first a classified House Intelligence Committee letter and then a subpoena (which arrived Monday) demanding documents related to a new line of inquiry about the Federal Bureau of Investigation's Trump investigation. The deadline for complying with the subpoena was Thursday afternoon, and the Justice Department flouted it. As the White House is undoubtedly monitoring any new congressional demands for information, it is likely that President Trump's tweet Wednesday ripping the department for not turning over documents was in part a reference to this latest demand.

Republicans also demand the FBI drop any objections to declassifying a section of the recently issued House Intelligence Committee report that deals with a briefing former FBI Director James Comey provided about former national security adviser Mike Flynn. House Republicans say Mr. Comey told them his own agents did not believe Mr. Flynn lied to them. On his book tour, Mr. Comey has said that isn't true. Someone isn't being honest. Is the FBI more interested in protecting the reputations of two former directors (the other being Mr. Mueller, who dragged Mr. Flynn into court on lying grounds) than in telling the public the truth?

It's hard to have any faith in the necessity of the more than 300 redactions in the House Intel report, most of which the Republican committee members insist are bogus and should be removed. On every occasion that Justice or the FBI has claimed material must be withheld for the sake of national security or continuing investigations, it has later come out that the only thing at stake were those institutions' reputations. Think the Comey memos, which showed the former director had little basis for claiming obstruction. Or Sen. Chuck Grassley's criminal referral of dossier author Christopher Steele, the FBI's so-called reliable source, whom we now know it had to fire for talking to the press and possibly lying. The Justice Department is laying all this at the feet of the Office of the Director of National Intelligence, which technically oversees redactions. But ODNI consults with the agency that "owns" the material, and the FBI is clearly doing the blocking. Again, many pieces of the House Intel report that are being hidden happen to relate to FBI conduct during the 2016 election.

The increasingly poisonous interaction between Congress and the Justice Department also stems from a growing list of questions Republicans have about leading Justice Department officials' roles in the events Congress seeks to investigate. Mr. Rosenstein's name was on at least one of the applications for a warrant on Carter Page to the Foreign Intelligence Surveillance Court. Dana Boente's name is on another, and he's now serving as the FBI's general counsel.

We can't know the precise motivations behind the Justice Department's and FBI's refusal to make key information public. But whether it is out of real concern over declassification or a desire to protect the institutions from embarrassment, the current leadership is about 20 steps behind this narrative. Mr. Comey, Peter Strzok, Lisa Page, Andrew McCabe —they have already shattered the FBI's reputation and public trust. There is nothing to be gained from pretending this is business as usual, or attempting to stem continued fallout by hiding further details.

This week's events—including more flat-out subpoena defiance—put a luminous spotlight on Speaker Paul Ryan. The credibility of the House's oversight authority is at stake. Mr. Ryan's committee chairmen have done remarkable work exposing FBI behavior, and they deserve backup. The quickest way to get Justice and FBI to comply with these legitimate requests is for Mr. Ryan to state strongly and publicly that he has zero qualms about proceeding down the road of contempt or impeachment if House demands are not met. This is the people's government, not the Justice Department's.

ROSENSTEIN: People making threats privately and publicly against me for quite some time. And I think they should understand by now the Department of Justice is not going to be extorted. We are going to do what's required by the rule of law and any kind of threats that anybody makes are not gonna effect the way we do our job. We have a responsibility. We take an oath. That's the whole point.

BRIAN: He is meaning we, he also means him. Rod Rosenstein firing back for House Republicans drafting articles of impeachment against him, which the Freedom Caucus says is a last resort if the DOJ continues to slow walk their document document requests as well as redacting things that make some of it incomprehensible. Joining us now is Florida Congressman Ron DeSantis who is running for governor in that state. How do you feel about the brush back pitch from Rod Rosenstein?

RON: I think it is a continuation of Rod Rosenstein showing contempt for Congress and our constitutional oversight responsibility. Remember, Brian, we have been going for these documents for months and months and months. And what they do they stonewall, stonewall, trickle some out. We say well, maybe we will hold you in contempt and they trickle some more out. RON: We want everything from the end of the Hillary case through Peter Strzok, McCabe, Comey, the whole lot of them. Ed Henry: Meanwhile republicans trey gowdy and bob goodlatte are probing comey's leaks, sending a letter to sessions and deputy attorney general Rosenstein seeking documents on a comey friend who was used to release some of him memos. rosenstein fired back at house republicans who are prepping those articles impeachment you mentioned against him for not producing other documents quickly enough. rosenstein said the department of justice is not going to be, his words, extorted meadows fired back that rosenstein should stick to facts and not rhetoric.

Shannon Bream: All right we are joined now by a member of the house freedom caucus the

group considering articles of impeachment against rosenstein. Matt gaetz is a republican congressman from florida. okay. so you probably heard a little bit from the deputy attorney general responding to this. i want to play more of what he had to say today when this topic came up.

**Rod Rosenstein:** There have been people who have been making threats privately and publicly against me for quite some time. and i think they should understand by now, the department of justice is not going to be extorted. we're going to do what's required by the rule of law.

Shannon Bream: What do you make of that? He says you're not going to be, or people who are making threats about his position are not going to be extorting the doj.

Matt Gaetz: Well, earlier you played a clip where rosenstein said no house republicans would put their names of these articles of impeachment. I think mr Rosenstein ought to be more worried about what he has put his name on. For example, the fisa warrant renewal after the fbi knew Christopher steele was lying and not trustworthy, rosenstein himself signed the document to spy on an american citizen with no justification. he also put his name on the pleading to silence the whistleblower in the uranium one case. Rod rosensteins definition of extortion seems to depart from the law. the definition of extortion is forcing someone to do something that they have no legal obligation to do under some threat. rod rosenstein has an obligation to follow the law, that's all we want him to do. and what's most telling about his viewpoint are his most recent comments to the new york times where he said he doesn't believe that the congress has a constitutional authority to conduct oversight. I think that means hes not reading article I correctly, particularly our power to appropriate funds, and then of course ensure that those funds are used in accordance with the law. here the fbi and department of justice departeded from the law. they did so because they were out to get donald trump. And now they want to evade oversight and its something were not going to let them do.

**Shannon Bream:** Let's talk about chairman goodlatte and gowdy have reached a deal with the doj to get production of documents to get they've been after for a long long time, it sounds like there's progress on some of these fronts as far as cooperation with the doj. why is that not enough?

Matt Gaetz: Because we're not getting the documents fast enough. we've requested 1.3 documents and we've received only a few thousand at a time. that's entirely inappropriate. now rosenstein has shown his cards. he doesn't believe that we have a constitutional ability to conduct oversight. i think the department of justice and the fbi know they did wrong in these fisa warrants that were based on false information where they were not disclosing all the facts to the court. they're hoping if this takes long enough and this survives to the november elections, there's a chance democrats will take control and then there will be no meaningful oversight, there will just be a witch hunt against the president. time is not our friend and that's why we need to act quickly

Shannon Bream: Quickly on this idea of the fall elections, which you mentioned, jennifer ruben says this, these people, meaning you guys, talking about impeachment are nuts and unfit to hold office. enough, vote them out, how does this factor into the fall?

Matt Gaetz: Well, she has one vote just like everybody else. the folks in my district and across the country are fed up with the mistreatment of our president. we've got a president who' out there trying to denuclearize the korean peninsula, to face iran, and he has to deal with this ludicrous investigation that was never on fact, where theres been no evidence of collusion, and which by the way, if there even was a prosecution, rosenstein would be a witness based on the questions that were released about comey's firing. so you can't oversee an investigation when you could potentially be a witness in that investigation. these aren't things that are nuts. we just want the law to be followed.

SANDRA: Attorney General Jeff Sessions reportedly threatening to resign if President Trump fires Deputy Attorney General Rod Rosenstein. That news coming from the Washington Post. This coming as a dozen republican lawmakers have written a letter to the Justice Department demanding a criminal investigation into James Comey and members of the Obama administration over their handling of the Clinton email probe. Here is republican congressman Ron DeSantis <u>on Sunday morning</u> futures.

DESANTIS: You look at somebody like Jim Comey. He testified before us in Congress that he did not decide to exonerate Hillary until after her interview and yet subsequent efforts of oversight unearthed the memo that he wrote two months before he interviewed Hillary that was an exoneration memo. Does the law apply equally to everybody or just anyone associated to Trump gets nailed?

SANDRA: That of course is the question with me now. Republican Congressman Jim Jordan of Ohio, he's a member of the House Oversight Committee. Honor to have you on set this morning, sir. What exactly is going on here and what are Republicans asking for?

JORDAN: A couple things. First of all Jim Comey has messed this thing up from the get go. I criticized him in July of 2016 when he did his big press conference. I criticized him again in October when he reopened the Clinton investigation. I think all throughout this process he has been wrong and sort of confirmed when you looked at some of the things he wrote in the memos that we got to see last week. One of the questions we have is on the Michael Cohen raid. Was the Attorney General consulted? Did Rod Rosenstein actually talk to the Attorney General? Because remember, his raid was run out of not under the umbrella of the special counsel but it was Rod Rosenstein according to press reports who has been the one who said let's go seek a warrant and actually raid, kick in the door of the president's lawyer. It seems to me when you do something like that, you should probably consult the Attorney General of the United States. We have a letter going this morning asking that question from a number of us to the Attorney General to find out about that as we move forward.

SANDRA: What if it's found that he was not consulted?

JORDAN: Either way he should have been consulted I think. Again, this is not just any lawyer we're talking about. We're talking about the lawyer for the President of the United States. Particularly in fact that it was not run under the as I said the umbrella of the special counsel. We'll see. It is an interesting point and we'll find out.

SANDRA: Reports now that Jeff sessions says that he may quit if Rod Rosenstein is fired. How would you describe the relationship right now between the DOJ and the White House? From our view it looks pretty tense.

JORDAN: It may be. You would have to ask Mr. Sessions and Mr. Rosenstein that. The relationship between Congress and the DOJ is not where it needs to be. We've been asking for documents for five months and to date we've received about 6,000 documents. When we met with Mr. Lausch, the new US attorney who is the point person that the Department has brought in to comply with document production to Congress, Mark Meadows and I met with him and other attorneys from the Department of Justice I asked him four simple questions, what's the approximate universe of documents we're entitled to, what's the current steps in the current process? How many people does it have to go through before we get it? What's the standard for redaction right now and the most important question, when will we get what Congress, a separate, equal branch is entitled to? **Their answers** were to all four questions I don't know. That's not really confidence inspiring. We've been at this now five months. Get us the information we're entitled to so we can get the answers more importantly to the American people.

SANDRA: Are you confident things are changing? As outsiders and those not in Congress, as American people hear that and they think that doesn't sound so good.

JORDAN: They're not changing fast enough, that's for sure. The idea that we did get to see the Comey memos and they have named a point person those are all steps in the right direction but you have to do it much faster and get the documents to us in a much more appropriate fashion without all the redactions we currently receive.

SANDRA: So Comey is accused of mishandling the investigation into Clinton's private email server, these 11 House Republicans also want to talk about Clinton and her campaign contributing payments that ultimately led to the creation of the dossier. Loretta Lynch among many others are mentioned in this letter. Where ultimately does this go, Congressman?

JORDAN: Hopefully we get answers. The one thing that drives the American people that drives them crazy more than anything else is the idea that there are two standards now. There is one set of rules for us regular folk and a different set if you're part of the politically connected class, like Clinton and Comey and Lynch and Lerner and that sort of thing. That has to change and that is why we need the documents to get the answers and to appropriately hold people accountable. It looks like now Andrew McCabe. Remember what happened at the top levels at the FBI. Jim Comey was fired. Deputy Director Andrew McCabe was fired and now potentially faces prosecution. Jim Baker former chief counsel at the FBI, demoted and reassigned. Peter Strzok, deputy head of counterintelligence, demoted and reassigned. Lisa Page, FBI counsel, demoted and reassigned. These are the top people at the FBI. When you have something like that go on, we need, as Congress, to get the information so we can ask the right questions and get answers for the American people.




FCI Hazelton, West Virginia on March 3rd, while conducting a routine fence check of the recreation yard (prior to inmate use), staff discovered a football between the perimeter fences. The football contained tobacco, marijuana, brown heroin, white heroin, Suboxone, and three cellular phones. On the same day, staff found a drone on the ground outside the secure perimeter. # JUSTICE DEPARTMENT SENDS 1373 COMPLIANCE LETTER TO CITY OF OAKLAND, DOCUMENT REQUEST AND SUBPOENA THREAT TO TWO OTHER JURISDICTIONS

WASHINGTON – The Department of Justice yesterday sent the attached letters to the City of Seattle, Washington, and the State of Vermont, demanding the production of documents that could show whether each jurisdiction is unlawfully restricting information sharing by its law enforcement officers with federal immigration authorities.

The Department of Justice previously contacted these jurisdictions and raised

concerns about laws, policies, or practices that may violate 8 U.S.C. § 1373, a federal statute that promotes information sharing related to immigration enforcement and with which compliance is a condition of FY2016 and FY2017 Byrne JAG awards.

The letters also state that failure to respond, respond completely, or respond in a timely manner will be subject to a Department of Justice subpoena.

The Justice Department also sent a letter to Mayor Libby Schaaf of the City of Oakland, regarding Oakland's laws, policies, or practices, which the Department believes may violate 8 U.S.C. 1373.

"When cities and states enact policies that thwart the federal government's ability to enforce federal immigration law, they choose to place the protection of criminal aliens over the safety of their communities," said Attorney General Jeff Sessions. "The Justice Department will not tolerate this intentional effort to undermine public safety and the rule of law, and I continue to remind all jurisdictions to reconsider policies that put their residents in harm's way."

Failure to comply with 8 U.S.C. 1373 could result in the Justice Department seeking the return of FY2016 grants, requiring additional conditions for receipt of any FY2017 Byrne JAG funding, and/or jurisdictions being deemed ineligible to receive FY2017 Byrne JAG funding.

The Department of Justice periodically reviews the laws, policies, or practices of jurisdictions that previously certified compliance with section 1373 as a condition of their FY2016 Byrne JAG awards.

In addition to these actions, the Justice Department also notified the District of Columbia and the Louisville-Jefferson (KY) County Metro Government that there is no evidence that either jurisdiction is currently out of compliance with section 1373.

The United States respectfully notifies the Court of its substantial interest in this suit and in public access to the summary judgment briefing and materials in this case. Plaintiff Students for Fair Admissions, Inc. ("SFFA") alleges that Harvard College has engaged in intentional discrimination against Asian Americans in its admissions process in violation of federal civil rights law. The public funds Harvard at a cost of millions of dollars each year, and thus has a paramount interest in any proof of these allegations, Harvard's responses to them, and the Court's resolution of this dispute. The Court therefore should ensure that these proceedings are open and accessible to the public consistent with the requirements of governing law.

## Nunes Statement on Access to FBI Electronic Communication

Washington, D.C. - House Permanent Select Committee on Intelligence Chairman Devin Nunes issued the following statement today:

"After numerous unfulfilled requests for an Electronic Communication (EC) related to the opening of the FBI's Russia counterintelligence probe, Chairman Trey Gowdy and I met this afternoon with Deputy Attomey General Rod Rosenstein. During the meeting, we were finally given access to a version of the EC that contained the information necessary to advance the Committee's ongoing investigation of the Department of Justice and FBI. -- Today, we have provided Chairman Nunes, Ranking Member Schiff, and all members of the committee with access to the requested document. Remaining redactions are narrowly tailored to protect the name of a foreign country and the name of a foreign agent; therefore, these redacted words have been replaced throughout the document with "foreign government official," "foreign government embassy," "foreign official," "foreign government," and "foreign government identifier" to ensure the document is as useful as possible to Congress. These words must remain redacted after determining that revealing the words could harm the national security of the American people by undermining the trust we have with this foreign nation. These words appear only a limited number of times, and do no obstruct the underlying meaning of the document. All other parts of the document are unredacted except the names of non-SES employees protected under the Privacy Act and a phone number.

--With this production, in conjunction with the 1,000 pages of classified materials—much of which is now being provided to entire HPSCI committee membership—we believe we have substantially satisfied Chairman Nunes August subpoena in an appropriate fashion. The Department will be pleased to continue to work with the Committee on other, related requests for information.

a few notes

My understanding is that folks at FOX would like more real time response to the show. So here are my notes:

- Its not a FISA that Nunes is asking for. It's the EC he wants unredacted—we've already provided him all the FISAs (he has not come to see them himself). He asked for some areas of this EC to be unredacted and we did. Now there's one paragraph that is still redacted—it protects the identity of a foreign government. So I'd like the hosts to acknowledge that we've provided all the FISAs and that this is about one paragraph in one document that implicates our foreign partners.
- Aisnley pronounced it RosenSTEEN. It's been a year now—surely she can pronounce his name correctly.
- 3. She said he's Mueller's best friend? What's the evidence for that? Or that they've ever even worked together?
- 4. Congress has oversight ability. No question. But that's different than being constitutionally entitled to all documents under DOJ possession. That's just not accurate according to MANY court opinions. There are two co-equal branches. Let me know if you need some of the court opinions on this.
- 5. "DOJ has not been helpful to capitol hill." We can/will do better on this Goodlatte request bc of the volume. But Nunes et all have gotten an ENORMOUS amount of material and access to dozens of witnesses that they've requested and have yet to interview them. So I'd like to see a little more acknowledgement that—they've seen FISAs, 302s, and talked to every witness they've wanted to. So this idea that we've never handed anything over is just completely false. And the one document that they threatened to hold the DAG in contempt for a few months ago and we relented, they've still never come over to see. So I know they send you these complaints but where's the followup from yall on what they have looked at and why they threatened to hold DOJ people in contempt for not providing witnesses and then 5 months later still haven't talked to any of them?
- 6. I know we've said this a thousand times—but the 1.2 million includes ALL emails for over a year from these employees. Most of it will be totally unrelated. PLEASE tell the hosts to stop saying we just need to hand over all the 1.2 million. Its not responsive to the subpoena and we can't under the law bc of grand jury material at a minimum. So clearly there has to be process to find the relevant documents. They're making it sound like it's a simple solution but its not and I think we've explained that sufficiently.
- 7. As to the redactions that they are complaining about—the only way they've seen the unredacted parts is because we have provided them. So clearly we are not hiding embarrassing materials, we are the ones producing it to them. But when its reported on the show its always in passive voice without any acknowledgement that when we send over material we tell them that they can request to see anything unredacted at DOJ.

The justice department said they delivered another three 3,600 pages to the house judiciary committee. this after failing to meet a subpoena deadline to produce more than 1 million documents related to the fbi's handling of the hillary clinton email probe, alleged fisa abuse, and the recommendation of to fire former fbi director andrew mccabe. the department is also expected to officially appoint a u.s. attorney to speed up the production of the documents. President Trump also tweeted this over the weekend. What does the DOJ and FBI have to hide? Why aren't they giving the strongly redacted documents (unredacted) to the HOUSE JUDICIARY COMMITTEE? Stalling, but for what reason? Not looking good! Chief intelligence correspondent catherine herridge is live in washington with the details. by my math we still have 1,000,196 and roughly 400 to go.

### **Catherine Herridge:**

The justice department says that big job is now going to go to a u.s. attorney who will be in the lead. he will have independent authority to oversee the process and make sure those records, some of which are months overdue are now provided to congress. he will answer directly to the attorney general. also the justice department chief spokesperson emphasized the records are sensitive, some sections may still be withheld or redacted but they get why everyone is so irritated.

### Sarah Isgur Flores:

I think members of congress and the president are understandably frustrated with the pace of production and some of the redaction's are seeing and i think it's important for the fbi and department to have credibility with congress, the president, and the american people.

#### **Catherine Herridge:**

The republican chairman of the house intelligence committee has given the department until wednesday to produce a clean copy of the fbi memo that kick started the russia probe. the department has produced some copies but each time sections were blacked out. also the republican chairman of the government oversight committee on the house wants to see a clean copy to understand the credibility of the intelligence as well as the sources.

#### Trey Gowdy:

It's important how this investigation began, when it began, and what is the credibility of the evidence upon which this investigation was launched and of the department of justice and the fbi have that document, they will not let us see the clean version and i'm struggling to understand why.

### Catherine Herridge:

For some context we've asked the justice department whether this is the first time they've had an appointment like this since 9/11 this electronic communication is so important is that it was drafted by fbi agent strzok or he was heavily involved.

#### Harris Faulkner:

Bret baier is right there on the left of your screen, great to see you today. one of the things i think we should start off with us to differentiate between where these documents are going and whether or not. when you hear the word unredacted, it's not because the public will see this, it's because the house judiciary committee will see it. what's the problem?

### **Brett Baier:**

There is a process here and a lot of these documents deal with classified material and they deal with some of them fisa material from the fisa court decisions and inside deliberations. there is a process it has to go through. why is it taking so long? who knows. they've had 54 fbi agents working on this supposedly working two shifts to try to produce these documents. the fact that 3600 documents are going over today is significant and brings you up to about 7,000 since january but now you have this u.s. attorney from the northern district of illinois who will oversee this process and luckily be public about where they are.

I'm fixing my number, now it is 1 million, 196,000. you know, why not -- i don't know if this is possible, i'm just trying to think outside the box. you've got 54 fbi agents, would it be easier just to raise the clearances for a temporary purpose of some of the house judiciary committee members so they can look at some of this stuff?

### Brett Baier:

I think there are some sensitivity to some of this concerns.

You don't know what we don't know about these documents and we should point out that the million plus it deals with a lot of redundancy. communications internally, the ig requested everything so they just dumped it to the inspector general, to actually come forward with specific requests about investigation documents, they have to go through that and i guess it takes time.

#### Harris Faulkner:

The ig has been doing some multitasking, going through the text messages of the people who were having an affair, the ig can do this but it is taking a tremendously long time, what do we know, what impact do we know this delay has on the process of justice? of learning what we need to know know.

### Brett Baier:

I don't know that we do know that, i think that report is really what we're waiting for. by all accounts it will be a blockbuster and will lay out the case about why andrew mccabe is gone. and the fbi director christopher wray said it was justified in numerous interviews. we will understand why when we see that inspector general's report but remember you've got a confluence of all this information, you've got this, the investigation, numerous investigations on the hill. the gym call me james comey book coming out this weekend, his story telling his take of everything. this ig report whenever it comes out. we will see how this all comes together. >>

## DOJ'S RESPONSE TO CALLS FOR A SECOND SPECIAL COUNSEL

The Attorney General appointed U.S. Attorney John Huber to review the FBI's decision-making in the Clinton e-mail investigation and other cases, and asked Inspector General Michael Horowitz to initiate a review of the FBI's use of FISA powers. Together these steps ensure that the Department of Justice appropriately and comprehensively addresses issues raised by Congress.

- U.S. Attorney Huber has the resources he needs to conduct an investigation from outside of Washington—including the full range of investigatory and subpoena powers. Huber may make recommendations as to whether a Special Counsel is necessary.
- IG Horowitz's job, as envisioned by Congress, is to investigate alleged wrongdoing of Department employees. Unlike a criminal investigation, his reports can be made public and can expose violations of Department policy that fall short of criminal conduct.

**ISSUE**—Approximately 39 Members of Congress have called on the Department to appoint a second Special Counsel to investigate a range of matters, including the handling of the Hillary Clinton E-Mail Investigation and the alleged misuse of the "Steele Dossier" in a FISA application. The Department's leadership takes these concerns seriously.

**REGULATIONS**—The Department must follow and enforce laws and regulations fairly and objectively. The authority to appoint a Special Counsel is governed by federal regulations.<sup>i</sup>

- Those regulations state that the Attorney General will appoint a Special Counsel when he determines that:
  - Criminal investigation of a person or matter is warranted;
  - An investigation would present a conflict of interest for the Department or in other "extraordinary circumstances"; and
  - Under the circumstances, it would be in the public interest to appoint an outside Special Counsel to assume responsibility for the matter.
- The regulations recognize that some matters, though sensitive or unusual, might not necessitate special counsel. When matters are brought to the attention of the Attorney General that might warrant consideration of appointment of a Special Counsel, the Attorney General may:
  - Appoint a Special Counsel;
  - Direct that an initial investigation, consisting of factual inquiry or legal research, be conducted in order to better inform the decision; or
  - Conclude that under the circumstances, the public interest would not be served by removing the investigation from the normal processes of the Department. He may direct other "appropriate steps" to mitigate conflicts of interest, such as recusal of particular officials.<sup>ii</sup>

The relevant regulation was promulgated in 1999, and the high standard for appointment of a special counsel has since been met in only two cases. (The Independent Counsel statute expired in 1999. Special counsels, like US Attorneys, report to Department of Justice leadership and rely on FBI personnel for investigations.)

**THE ATTORNEY GENERAL'S TWO-PRONG RESPONSE**—First, the Attorney General designated a federal prosecutor to conduct a review of the issues raised by the Chairmen and report back as to whether the appointment of a special counsel is appropriate.

- In November, the Department announced that the Attorney General had directed senior federal prosecutors to evaluate the issues raised by Members and "make recommendations as to whether any matters not currently under investigation should be opened, whether any matters currently under investigation require further resources, or whether any matters merit the appointment of a Special Counsel."
- In March, the Department announced that U.S. Attorney John Huber, a federal prosecutor in Utah, has been conducting the review.
  - Huber is an experienced federal prosecutor who was twice confirmed unanimously by the Senate as United States Attorney for the District of Utah in 2015 and 2017.
  - Huber is conducting his review outside of Washington and is cooperating with the Inspector General.
  - Huber has the full range of investigatory powers at his disposal, including subpoena power.
  - Huber has been promised any resources he needs and is conducting his investigation from Utah.

Second, the Attorney General asked the Department's Inspector General, Michael E. Horowitz, to review the Department's compliance with certain legal requirements and Department and FBI policies and procedures with respect to certain applications filed with the U.S. Foreign Intelligence Surveillance Court. The Office of Inspector General announced the initiation of this review on March 28, 2018.<sup>iii</sup>

- Congress created the Office of Inspector General (OIG) explicitly for the purpose of, among other things, investigating alleged violations of criminal and civil laws by Department employees, including actions taken by employees who have since left government service.
- The Inspector General's jurisdiction extends not only to allegations of legal violations, but also to allegations that Department employees violated established policies.
- The Department's OIG employs approximately 470 staff, a significant number of whom are lawyers, auditors, and investigators who may exercise wide discretion on matters under their jurisdiction. If the IG finds evidence of criminal wrongdoing, he may refer it to a United States Attorney who can then convene a grand jury or take other appropriate action.

- OIG may issue public reports exposing wrongdoing that violates Department policy but falls short of criminal conduct. By contrast, the public would not typically know of a traditional criminal investigation that resulted in no criminal charges.
- The Office of Inspector General announced the initiation of his review on March 28, 2018.<sup>iv</sup>

### THANK YOU, JEFF SESSIONS

A capable U.S. attorney is a far better choice than a second special counsel.

What does Jeff Sessions have to do to get a nice tweet from his boss?

On Thursday the attorney general released a letter informing Congress that he'd asked Utah-based U.S. Attorney John Huber to investigate lawmakers' complaints about the Justice Department and the FBI. Turns out Mr. Huber has been working on this investigation, in concert with the Justice Department's inspector general, since November. The news of Mr. Huber's appointment came two days after a statement from FBI Director Christopher Wray confirming a similar push by Mr. Sessions to get agents responding to congressional subpoenas off their tuchuses.

Notwithstanding the thin news coverage, these are big steps. Yet few on the GOP side seemed pleased. Though Sen. Ron Johnson (R., Wis.) specifically said Sunday on NBC's "Meet the Press" that he was delighted Mr. Sessions had not opted for a second special counsel to look into allegations of FBI misconduct in its probe into Hillary Clinton's emails and its application for a warrant to spy on a Trump campaign associate, other Republicans groused.

Then there's the president. While Donald Trump remains silent (for now at least) about the appointment of Mr. Huber, on Monday morning he tweeted another dig at his attorney general's leadership:

"So sad that the Department of 'Justice' and the FBI are slow walking, or even not giving, the unredacted documents requested by Congress. An embarrassment to our country!"

Mr. Trump is right about the slow-walking of files in defiance of congressional subpoenas. He's also right that critical info has been redacted from documents sent to Capitol Hill. This includes the lively little text chat between FBI paramours Peter Strzok and Lisa Page about how they might arrange to meet with a Foreign Intelligence Surveillance Court judge while making it appear accidental.

Still, the president is behind the curve. To begin with, the only reason Mr. Wray has promised the FBI will do better is because Mr. Sessions leaned on him. More to the point, this is a problem the president could easily resolve himself, by using his authority to declassify material as well as assigning someone not only to get Congress the information it seeks but to review all redacted material to see what the bureaucrats are hiding.

As for Mr. Huber, though his appointment elicited barely a yawn in the news cycles, this is not a mistake the FBI's recently sacked deputy director, Andrew McCabe, is making. Could it be that Mr. McCabe established a GoFundMe legal defense fund—which now has more than half a million dollars in it—because he knows what is in that soon-to-be-released inspector general's report?

Those disappointed with Mr. Sessions's decision don't seem to recognize that Mr. Huber has pretty much the same powers that Robert Mueller enjoys: to get search warrants, to subpoen witnesses and documents, and to ask a grand jury to indict. The only advantages of a special counsel are ones that should be discouraged: an Inspector Javert-like focus on a single target or set of targets that goes on much longer than it should and strays far from the original mandate.

Like so many other bad ideas that plague American political life, the special counsel as we conceive of it today is the bastard son of the Nixon era. After the initial Watergate prosecutors were thought to lack sufficient independence in going after the president, Congress during the Jimmy Carter era passed the Ethics in Government Act, which provided for the appointment of a truly independent special prosecutor.

The only good thing to come out of this terrible law was Justice Antonin Scalia's brilliant and solitary dissent savaging it in Morrison v. Olson (1988) arguably his finest opinion. In 1999, after unhappy bipartisan experience with independent counsels, Congress let the provision lapse. Now special counsels such as Mr. Mueller are more limited legal beasts.

But it remains a dreadful idea. As former assistant U.S. attorney Andrew McCarthy notes, if a special counsel is truly "special"—i.e., not accountable to the president like every other executive employee—then he is constitutionally suspect. If he's not special, it is unclear why he is an improvement over any capable U.S. attorney.

For Congress, the even bigger problem is the conflict between the goals of a special counsel (indictments) and the exercise of legislative oversight (political accountability). In his "Meet the Press" interview Sunday, Sen. Johnson noted that the primary casualty of this clash is public disclosure. Note to GOP members: If you think the FBI and Justice Department are arrogant about sharing information, see what happens when a special counsel moves in.

By reading the riot act to his reluctant FBI director and shunning the appointment of another special counsel, Mr. Sessions has rendered a service to the Constitution, to good government and even to Mr. Trump, though he may not realize it. Perhaps even worthy of a celebratory presidential tweet.

#### Jonathan Turley:

He didn't foreclose the possibility of a Special Counsel. What the Attorney General said is that he is having a U.S. Attorney essentially team up with the Inspector General within the Justice Department to investigate these matters. I actually think it's the right decision. I think the President should listen to General Sessions on this. He can appoint a Special Counsel later. If I were Andrew McCabe, I would not be happy with this. You have a U.S. Attorney outside of Washington who has the ability to prosecute cases, who is working with an Inspector General who has already made findings against McCabe. That's not a good situation for him and probably not a good situation for James Comey.

#### Stuart Varney:

Do these prosecutors have the same power to investigate and get to the bottom of things that a Special Counsel would have?

Turley:

Actually, yes. I think people are missing what may be a brilliant move here by Sessions. What he did is he essentially combined the powers of the Inspector General with the powers of a line prosecutor. This prosecutor does have not just the experience and training to look for a criminal case, he has the ability to move a case of that kind. Moreover, if he finds that crimes were committed and many people of the FBI might be implicated, Sessions reserved the right to go ahead and appoint a Special Counsel. That's a powerful combination. There's a great deal here that we're waiting for. The Inspector General still has the ability to refer McCabe for prosecution. He -- what we know is that whatever was in that report of his led FBI Director Wray to essentially force him into terminal retirement. It led Session to fire him. But if he in fact did lie to investigators or misled them, he could still be referred to for criminal charges.

#### Varney:

I believe that the Utah prosecutor, Mr. Huber, and Michael Horowitz both are Obama holdovers and they're investigating the Obama administration. Now a lot of people would call that sort of an implied conflict of interest. you don't see that?

#### Turley

I don't. I don't know Mr. Horowitz or Mr. Huber personally. I have certainly know of them. They both have very good reputations. Horowitz has already gone after McCabe. He is known as a dogged investigator. Huber doesn't have any skin in the game. He's not part of the beltway, he's not part of what people usually refer to as the deep state. He's -- that distance between him and Washington is very important. I don't know of anyone who suggested that either one of these gentleman is partisan actor.

Varney:

These messages, the latest text messages between Strzok and Page, they appear to bring President Obama, their top level of the Administration, into play, if I can put it like that. Do you see it that way?

Turley:

It may. And in fact that's one of the reasons I think this is the better approach. If a Special Counsel were appointed, there would be a great deal of delay as we pursue these types of allegations. They're already pursuing them. They've got staff on the scene and able to acquire this evidence. People like McCabe were close to retirement. So time may be of the essence. So I do think this is something they must look at. And it obviously raises troubling issues.<sup>vi</sup>

## HOUSE JUDICIARY COMMITTEE SUBPOENA

On March 22, 2018, the House Committee on the Judiciary issued a subpoena to compel nine categories of documents. The Department has been far more responsive to these requests than has been reported.

The Subpoena requests a significant number of documents that the Department is already in the process of producing<sup>1</sup> or has already produced to the Committee through *in camera* reviews. In certain cases, the Subpoena requests documents for the first time, a significant deviation from the traditional Congressional oversight accommodation process.

### **Summary of Requests & Production**

Paragraph One:	Requesting documents and communications provided to or obtained by the Department's IG regarding the FBI's decision-making with respect to the FBI's investigation of former Secretary Clinton's private email server.
	• Requests from the IG arising from an internal investigation can include documents obtained through a date search of specific employee's e-mails and phones. This means that <i>all</i> documents for that time period are collected—encompassing <i>all</i> communications about <i>all</i> potentially ongoing investigations that person may have been working on during that time. Of the approximately 1.2 million pages the IG collected, only a few thousand may be communications relevant to the investigation in question.
	• In January, the Department of Justice and FBI initiated a rolling production of responsive documents, reviewed and redacted as necessary. <sup>i</sup> <u>The Department has produced approximately 4,000 pages responsive to the request.<sup>ii</sup></u>
	• Upon specific request, the Department is allowing <i>in camera</i> reviews of unredacted materials, when appropriate.
	• At the Attorney General's request, FBI Director Chris Wray doubled from 27 to 54 the number of FBI staff working on this request. They are working two shifts a day from 8:00 a.m. to midnight.
	• On March 30, 2018, the FBI General Counsel provided the Committee with a detailed written explanation of the review process and the purpose of redactions.
	• In August and September 2016, the FBI provided the Committee its letterhead memo—a 32-page, single-spaced document describing the FBI's investigation pertaining to Clinton's use of a private e-mail server —and 47 FBI 302s. These include the 302 pertaining to the interview with Clinton.

Of note, an August 2016 text exchange that seems to indicate Page and Strzok discussed possible codenames for a Trump probe. We understand an earlier letter to the DAG March 14, suggested redaction standards are not being met.

Dear Mr. Sessions:

As you know, the Committee on Oversight and Government Reform on which I serve has a constitutional duty to conduct oversight of the FBI and the broader Department of Justice. In recent months, this constitutional duty has required an investigation into the potentially improper conduct of high-ranking FBI officials investigating both Hillary Clinton's private email server and the Trump campaign's alleged contacts with Russia.

Over the course of this investigation, I have repeatedly raised concerns that the Department of Justice and FBI have not addressed our oversight requests in good faith. Specifically, recent document productions demonstrate the Department has redacted material facts critical to our understanding of the events underlying the investigation.

While I appreciate the Department's invitation to review less-redacted documents *in camera*, additional investigative follow-up I have personally conducted related to the documents has revealed some of the still redacted information to be probative and highly relevant to a full understanding of the issues at hand.

To illustrate this point, the following examples contain material information which had originally been redacted in your productions to Congress:

 In camera review of text messages exchanged by Peter Strzok and Lisa Page revealed Peter Strzok had a personal relationship with Rudolph Contreras, a judge on the FISC.<sup>1</sup> Additionally, Strzok and Page engaged in further commentary related to whether this friendship meant Strzok had a possible conflict of interest or should have considered recusal.<sup>2</sup>

- 2. I have previously raised concerns as to why the name of an individual who allegedly said: "The White House is running this" was redacted.<sup>3</sup> Considering the mandate of this investigation is to examine whether FBI employees engaged in potentially inappropriate decision-making in 2016, conversations referring to the White House potentially "running" any aspect of the FBI's impartial investigative function are critical for understanding the broader context.
- 3. On August 14, 2016, Lisa Page texted Peter Strzok she thought an "article so rings true that then I think the CHS [*redacted initialism* meaning confidential human source] is wrong."<sup>4</sup> Concerns related to the reliability of the initial information the confidential human source provided the FBI in the early stages of the investigation are material and should not have been redacted.
- 4. In recent weeks, the Department has told us non-supervisory employees' names were redacted from the production. However, information redacted from texts sent on August 30, 2016, reveals Lisa Page and Peter Strzok were talking about briefing Denis McDonough, President Obama's White House Chief of Staff.<sup>5</sup>
- 5. Similarly, David Laufman, the former chief of the Department of Justice's National Security Division's Counterintelligence and Export Control Section, was redacted from the Department's production of the texts exchanged between Lisa Page and Peter Strzok. Considering Mr. Laufman helped oversee investigations into Hillary Clinton's private email server and alleged contacts between the Trump campaign and Russia, mentions of him in the documents are material.
- 6. In camera review of texts also reveals numerous mentions of an "Andy," an apparent reference to Andrew McCabe, were also redacted. As Deputy Director, and eventually Acting Director of the FBI, Mr. McCabe was not only in a supervisory role, but was at one point the top official at the FBI. As such, he should not have been redacted at any point in the documents.
- 7. In camera review of texts from September 14, 2016, reveal Strzok texted Page "BTW I can't stand Laufman. DOJ jumped in the middle of our agency coordination to lobby for their extra guy. Now Legat looks like [expletive]."<sup>6</sup> When Strzok elaborates on his conversation with Mr. Laufman, there is a long redacted sentence, followed by "Claims edva is (/was) the delay."<sup>7</sup>

- a. These redactions raise concerns on several levels. A conversation between Legat, the FBI's overseas offices, and DOJ during inter-agency coordination for the investigation is material to understanding the initial decisions made by FBI and DOJ.
- b. Additionally, Strzok's mention of a DOJ official saying the EDVA (Eastern District of Virginia), the court whose prosecutors issued subpoenas and took other investigative steps related to the investigation of alleged contacts between Russia and the Trump campaign, was the reason for the "delay" is deeply concerning. Specifically, talk of a "delay" related to the Eastern District of Virginia's exercise of its prosecutorial discretion raise concerns of undue influence from the FBI.
- 8. On August 11, 2016, Lisa Page and Peter Strzok engaged in a conversation about potential codenames they would use throughout the course of the investigation.
  - a. During this conversation, Strzok says: "YUUUGE... though we may save that for the man, if we ever open on him"<sup>8</sup> in an apparent reference to President Trump. The next text Strzok sent is: "OMG I CANNOT BELIEVE WE ARE SERIOUSLY LOOKING AT THESE ALLEGATIONS AND THE PERVASIVE CONNECTIONS."<sup>9</sup> This evidence of bias exhibited by the FBI agents investigating President Trump borders on animus. Potential conflicts of interest are material in the context of conducting oversight related to the integrity of the FBI's decision making with this investigation.
- 9. As you are well aware, there is evidence political opposition research was used in court filings for this investigation. There is also evidence this same political opposition research was not properly vetted before it was used nor fully revealed to the court. As such, serious concerns have arisen related to the integrity and public confidence in the protocol behind certain counterintelligence programs and the FBI officials tasked with implementing them.
  - a. Given these concerns, Peter Strzok's October 11, 2016 text to Lisa Page that he was "currently fighting with Stu for this FISA"<sup>10</sup> raises concerns. As you are probably aware, Stu Evans was head of DOJ's National Security Division in October 2016. This redacted text raises serious concerns of undue influence or pressure being exerted from one agency to another, giving it substantial probative value.

10. Documents provided by the Department of Justice demonstrate Peter Strzok was conducting interviews in late July and early August 2016 with FBI sources related to the early stages of the investigation into alleged contacts between the Trump campaign and Russia. On August 2, 2016, Peter Strzok sent Lisa Page a text saying: "interesting fact. Guy we're about to interview was [redacted]."<sup>11</sup> This redacted portion appears to present material information related to the initial steps of the investigation.

The examples shown are not designed to be an exhaustive list of inappropriate redactions. This is just a sampling of some of the relevant material facts that have been redacted under the guise of personal and non-relevant information.

I have great respect and admiration for the rank-and-file law enforcement professionals who serve our country at the FBI and broader Department of Justice. As such, I fully support the Department's choice to remove their names from Congressional document productions for the sake of protecting individual employees' privacy. However, the redaction of supervisory FBI and DOJ officials' names from these documents has left congressional investigators unable to understand the underlying events of the investigation.

Information related to potential conflicts of interests and bias, the possible exertion of improper pressure between agencies in the coordination of an investigation, and the reliability of evidence presented by FBI agents in federal court are material in nature and should not be redacted. The potential sensitivity of law-enforcement related information produced to Congress is far outweighed by the American public's right to a fair and impartial FBI.

We have inquired about this issue with your office previously in a letter dated March 14, 2018, and have received little to no explanation for the current processes in place. The current system the Department has in place, which has produced documents with excessive redactions, has wasted my time and left me unable to fulfill my obligation to conduct oversight to the extent. the Constitution requires. This needs to change.

Your immediate attention to this matter is requested. Please provide my office with a response by April 13, 2018.

## ATTORNEY GENERAL ANNOUNCES ZERO-TOLERANCE POLICY FOR CRIMINAL ILLEGAL ENTRY

Attorney General Jeff Sessions today notified all U.S. Attorney's Offices along the Southwest Border of a new "zerotolerance policy" for offenses under 8 U.S.C. § 1325(a), which prohibits both attempted illegal entry and illegal entry into the United States by an alien. The implementation of the Attorney General's zero-tolerance policy comes as the Department of Homeland Security reported a 203 percent increase in illegal border crossings from March 2017 to March 2018, and a 37 percent increase from February 2018 to March 2018—the largest month-to-month increase since 2011.

"The situation at our Southwest Border is unacceptable. Congress has failed to pass effective legislation that serves the national interest—that closes dangerous loopholes and fully funds a wall along our southern border. As a result, a crisis has erupted at our Southwest Border that necessitates an escalated effort to prosecute those who choose to illegally cross our border," said Attorney General Jeff Sessions. "To those who wish to challenge the Trump Administration's commitment to public safety, national security, and the rule of law, I warn you: illegally entering this country will not be rewarded, but will instead be met with the full prosecutorial powers of the Department of Justice. To the Department's prosecutors, I urge you: promoting and enforcing the rule of law is vital to protecting a nation, its borders, and its citizens. You play a critical part in fulfilling these goals, and I thank you for your continued efforts in seeing to it that our laws—and as a result, our nation—are respected."

On April 11, 2017, Attorney General Jeff Sessions announced a renewed commitment to criminal immigration enforcement. As part of that announcement, the Attorney General issued a memorandum to all federal prosecutors and directed them to prioritize the prosecution of certain criminal immigration offenses. Today's zero-tolerance policy further directs each U.S. Attorney's Office along the Southwest Border (i.e., Southern District of California, District of Arizona, District of New Mexico, Western District of Texas, and the Southern District of Texas) to adopt a policy to prosecute all Department of Homeland Security referrals of section 1325(a) violations, to the extent practicable.

## MEMORANDUM FOR FEDERAL PROSECUTORS ALONG THE SOUTHWEST BORDER

THE ATTORNEY GENERAL

SUBJECT:

Zero-Tolerance for Offenses Under 8 U.S.C. § 1325(a)

On April 11, 2017, I issued a memorandum to all federal prosecutors entitled "Renewed Commitment to Criminal Immigration Enforcement," in which I directed the prioritization of the prosecution of certain criminal immigration offenses. I further directed each United States Attorney's Office along the Southwest Border to work with the Department of Homeland Security to develop guidelines for prosecuting offenses under 8 U.S.C. § 1325(a).

Those seeking to further an illegal goal constantly alter their tactics to take advantage of weak points. That means we must effectively respond with smart changes also. The recent increase in aliens illegally crossing our Southwest Border requires an updated approach. Past prosecution initiatives in certain districts—such as Operation Streamline—led to a decrease in illegal activities in those districts. We must continue to execute effective policies to meet new challenges.

Accordingly, I direct each United States Attorney's Office along the Southwest Border to the extent practicable, and in consultation with DHS— to adopt immediately a zero-tolerance policy for all offenses referred for prosecution under section 1325(a). This zero-tolerance policy shall supersede any existing policies. If adopting such a policy requires additional resources, each office shall identify and request such additional resources.

You are on the front lines of this battle. I respect you and your team. Your dedication and insight into border reality is invaluable. Keep us informed, and don't hesitate to give us suggestions for improvement. Remember, our goal is not simply more cases. It is to end the illegality in our immigration system.

This guidance is not intended to, does not, and may not be relied upon to create, any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

## JUSTICE DEPARTMENT SEEKS TO DENATURALIZE TWO FOREIGN-CONVICTED WAR CRIMINALS WHO FRAUDULENTLY OBTAINED REFUGEE STATUS AND NATURALIZED INTO U.S. CITIZENSHIP

## Defendants Concealed that They Had Murdered Civilians and Prisoners of War During the 1990s Balkans Conflict

WASHINGTON – The Justice Department today filed denaturalization lawsuits against two convicted war criminals and natives of the former Yugoslavia, who according to the Department's complaints, murdered civilians and prisoners of war because of their religion and ethnicity, then fraudulently obtained refugee status and later naturalized into U.S. citizenship by concealing their crimes. The civil complaints were filed in federal court in the District of Oregon and the District of Columbia.

"War criminals will find no safe haven or shelter within the United States," said Attorney General Jeff Sessions. "We will be steadfast as we investigate and prosecute human rights violators, torturers, and war criminals. This is especially true for those who fraudulently obtain U.S. citizenship. For too long, we have tolerated egregious fraud in our refugee program, our immigration system, and the naturalization process. This Administration will hold alleged fraudsters accountable." "We at DHS are committed to working with our partners across the federal government to target those who seek to break our immigration laws to obtain U.S. citizenship. There will be consequences," said Secretary Kirstjen Nielsen from the Department of Homeland Security. "National security is homeland security and fraudulently obtaining U.S. citizenship will not be tolerated. Those who abuse our generous immigration system take opportunities away from those who follow our laws and who undoubtedly deserve U.S. citizenship."

Today's lawsuits allege that Edin Dzeko, 46, and Sammy Rasema Yetisen, aka Rasema Handanovic, aka Zolja, 45, were part of an elite unit of the Army of the Republic of Bosnia and Herzegovina that attacked the village of Trusina on April 16, 1993, in what is known as the Trusina massacre. The unit targeted Bosnian Croats who resided in the village because of their Christian religion and Croat ethnicity, killing 22 unarmed individuals including women and the elderly. A Bosnian court previously found that Dzeko and Yetisen played key roles in the massacre: both were part of a firing squad that executed six unarmed prisoners of war and civilians, and Yetisen proceeded to make sure all six were dead by shooting them again. In addition to his participation in the firing squad, Dzeko also killed a crippled elderly man, and then shot the man's wife in the back, killing her because she would not stop crying.

According to the complaints, Dzeko's and Yetisen's actions came to light in 2011 when the United States granted their extradition to Bosnia and Herzegovina at that country's treatybased request. In April 2012, Yetisen was convicted in a Bosnia court pursuant to a guilty plea of war crimes against prisoners of war and war crimes against civilians based on the firing squad execution-style killings. In exchange for her plea and cooperation, Yetisen was sentenced to five years and six months in prison. In June 2014, Dzeko was convicted in Bosnia court of war crimes against prisoners of war and war crimes against civilians, and held responsible for the eight killings described above, in part based on Yetisen's testimony against him. Yetisen has been released from prison and resides in Oregon. Dzeko is still serving his sentence in Bosnia and Herzegovina.

Before their war crimes had come to light, Dzeko and Yetisen each requested and received refugee status from the United States, claiming themselves to be victims of persecution. The complaints allege that Dzeko and Yetisen concealed and affirmatively misrepresented their criminal history, military service, and persecutory acts throughout their immigration proceedings. Such benefits would have been denied had immigration authorities known about the defendants' roles in the Trusina massacre.

"The United States has been a safe haven and symbol of hope for people fleeing from persecution, not for war criminals," said U.S. Attorner Jassie K. Liu of the District of Columbia "The actions taken in the District of Columbia and in Oregon today demonstrate that we will use every tool to ensure the integrity of our refugee programs."

"The United States is a refuge for those fleeing violence and the atrocities of war, not those responsible for these unthinkable acts," said U.S. Attorney Billy J. Williams of the District of Oregon. "I applaud the hard work and coordination of law enforcement across the country that culminated in these lawsuits."

Today's civil denaturalization cases follow on the <u>recent</u> <u>criminal conviction</u> of a Bosnia Serb residing in North Carolina for making materially false claims and statements on his initial application for refugee status, which involved similar concealment of service in a military unit involved in the July 1995 Srebrenica massacre that resulted in the deaths of between 7,000 and 8,000 Bosnian Muslim men.

The cases were investigated by U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations Human Rights Violator and War Crimes Unit and the Civil Division's Office of Immigration Litigation, District Court Section (OIL-DCS) National Security and Affirmative Litigation Unit (NS/A Unit), with consultation and support from ICE's Office of the Principal Legal Advisor (OPLA) Human Rights Law Section and Seattle Office of the Chief Counsel, and the Criminal Division's Human Rights and Special Prosecutions Section.

The cases are being jointly prosecuted by Deputy Chief Timothy Belsan and Senior Counsel for National Security Aram Gavoor of OIL-DCS's NS/A Unit and Trial Attorney Steven Platt of OIL-DCS, Assistant U.S. Attorney Wynne Kelly of the U.S. Attorney's Office for the District of Columbia, and Assistant U.S. Attorney Jim Cox of the U.S. Attorney's Office for the District of Oregon.

The claims made in these complaints are allegations only, and there have been no determinations of liability.
