To the extent the original confirmation hearing date falls outside the time period under 11 U.S.C. § 1324(b), you are required to **obtain a new confirmation hearing date (and objection deadline)** and serve notice of the new confirmation hearing date along with the Notice of Rescheduled Meeting of Creditors.
