Defendant Warwick was sentenced to 37 months imprisonment,
 not 51 months as currently indicated.

The government also notes that as previously set forth in Docket Entry 368, defendant Warwick's sentence was calculated based on the November 2002 Sentencing Guidelines, which calculated FCPA offenses under a more lenient standard set forth in § 2B4.1.1, containing a base offense level of 8. After November 2002, Section 2C1.1, which currently as a base offense level of 12, became the applicable sentencing guidelines section. The government apologizes for any inconvenience to the Court from this error.
